Court's decision in the abortion rights case, including the broader right of privacy—which landmark LGBTQ cases rely upon for their constitutional roots.

Professor Murray is a leading scholar and trailblazer of constitutional law, reproductive rights, and justice. She is the current co-host of the popular podcast, Strict Scrutiny. She dedicates her expertise to award-winning research focusing on the legal regulation of sex, sexuality, marriage, reproductive rights, and justice.

Murray earned her law degree from Yale Law School, and currently serves as the Frederick I. and Grace Stokes Professor of Law at New York University (NYU) School of Law. Prior to NYU, Murray clerked for then-judge Sonia Sotomayor. Additionally, she was the Alexander F. and May T. Morrison Professor of Law and Interim Dean of Berkeley Law, and the first Black woman to lead a top-ten law school. Murray's articles have appeared in leading law journals, including the Harvard Law Review, the Yale Law Journal, and the Columbia Law Review.
